Approve an Ordinance authorizing the City Manager to execute a quitclaim (tax resale) deed conveying all right, title and interest in real property located at 300 Arroyo Grande, to **F & F General Contractor**

BACKGROUND / DISCUSSION:

The property being sold is referred to as a "struck off" property because it was bid off to the City at a tax sale when no bids were received. An offer has been made to purchase the property for the full amount of the judgment in accordance with Section 34.05 (h) of the Tax Code. Section 34.05 (h) permits the City to sell a property for the total amount of the judgment and the sale of the property does not require the consent of each taxing entity entitled to receive proceeds from the sale. If the sale is approved the property will be put back on the tax rolls to generate revenue.

Yes, Council has considered this type of offer for struck off properties and approved the same type of ordinance for other struck off properties.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

That the City Manager is hereby authorized to execute a Quitclaim (Tax Resale) Deed conveying to **F & F General Contractor**, all of the right, title, and interest of the City of El Paso, and all other taxing units interested in the tax foreclosure judgment in the following described real property:

3563 Square Feet, more or less, out of Lot 1, Block 2, River Valley Estates, to complement 11,000 square feet for parcel to be known as Lot 9, Block 2 River Valley Estates, Replat A, being more particularly described by metes and bounds in Volume 1454, Page 11, Deed Records of El Paso County, Texas.






