Hello Day Cafe is seeking permission to sell and serve alcoholic beverages within the closed portions of City right-of-way during Melt: Last Saturdays Downtown. Hello Day Cafe has authorized Tricky Falls/Bowie Feathers to sell and serve the alcoholic beverages on their behalf during the event from 3:00 pm Saturday, July 27, 2013 through 1:00 am Sunday, July 28, 2013.

A special privilege permit (NESV13-00020) was approved by the Downtown Management District (DMD) AdHoc committee for the temporary street closure.

**R E S O L U T I O N**

**WHEREAS**, Hello Day Cafe (hereinafter referred to as “Grantee”) is sponsoring Melt: Last Saturdays Downtown from 11:00 am Saturday, July 27, 2013 through 3:00 am Sunday, July 28, 2013 (hereinafter referred to as “Event”); and

**WHEREAS**, the City is not a sponsor of the Event and the Grantee assumes full responsibility for the planning, coordination, management and production of the Event; and

**WHEREAS**, the Grantee has authorized the Tricky Falls/Bowie Feathers (hereinafter referred as “Licensee”) to provide for the sale and service of alcoholic beverages during the Event; and

**WHEREAS**, the Grantee has received administrative approval for a Special Privilege Permit for the use and closure of City rights-of-way for less than twenty-four (24) hours on portions of City rights-of-way on South El Paso Street between West San Antonio Avenue and East Overland Avenue, 11:00 am Saturday, July 27, 2013 through 3:00 am Sunday, July 28, 2013, in conjunction with the proposed Event; and

**WHEREAS**, both the Grantee and Licensee desire to provide for the sale and service of alcoholic beverages on the closed portions of City rights-of-way during the Event; and

**WHEREAS**, the Texas Alcoholic Beverage Commission requires that the City Council for the City of El Paso approve, as a permissible activity, the sale and service of alcoholic beverages during the City Event.

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

That the sale and service of alcoholic beverages by Hello Day Cafe and Tricky Falls/Bowie Feathers, in the closed portions of City rights-of-way on South El Paso Street between West San Antonio Avenue and East Overland Avenue, from 3:00 pm Saturday, July 27, 2013 through 1:00 am Sunday, July 28, 2013 is a permissible activity in conjunction with Melt: Last Saturdays Downtown.
