

RELEASE

WHEREAS, in accordance with Section 9.04.380, entitled Abatement, of the El Paso City Code, after providing due notice to the owner of the hereinafter described property that the owner's property constituted a public nuisance due to the accumulation of trash, vegetation and weeds or other objectionable, unsightly or unsanitary matter in violation of the El Paso City Code, and the owner failed to comply after due notice, the City's Department of Solid Waste Management proceeded to clean and dispose of the trash, vegetation, weeds and/or other rubbish; and

WHEREAS, the El Paso City Council, in accordance with Section 9.04.380 of the El Paso City Code, declared the total amount of EIGHT HUNDRED THIRTY SIX AND 77/100 DOLLARS (\$ 836.77) to be liens on the hereinafter described property by Resolution dated January 3, 1995, and said Resolution is recorded in Book 2865, Page 1779, of the Deeds Records of El Paso County, Texas; and the El Paso City Council, in accordance with Section 9.04.380 of the El Paso City Code, and by Resolution dated August 19, 1997, and said Resolution is recorded in Book 3244, Page 1034 of the Deeds Records of El Paso County, Texas; and by Resolution dated April 13, 2004, and said Resolution is recorded in Book 4892, Page 0907 of the Deeds Records of El Paso County, Texas; and

WHEREAS, the property owner desires a release of the property covered by said sanitation liens and has made satisfactory arrangement with the City of El Paso to justify said releases;
