1. INTRODUCTION OF ORDINANCES PURSUANT TO SECTION 3.9 OF THE EL PASO CITY CHARTER:

- 1A.** An Ordinance amending Title 20 (Zoning) Chapter 20.02 (General Provisions and Definitions), Article II, (Definitions) of the El Paso City Code to revise all the definitions related to signs. The penalty is as provided in Section 20.24 of the El Paso City Code. **(All Districts)** [Mayor John F. Cook, (915) 541-4145]
- 1B.** An Ordinance amending Title 20 (Zoning) Chapter 20.18 (Sign Regulations) of the El Paso City Code to amend articles I, II, III, and V to establish revised regulations for signs; to add definitions; to add provisions to limit the conversion of billboards to electronic displays; to extend the sign regulation to the city's extraterritorial jurisdiction; to amend provisions for construction of new billboards; to require registration of existing billboards; to address existing digital signs; to remove exemptions for governmental entities, and to establish appeal procedures. The penalty is as provided in Section 20.24 of the El Paso City Code. **(All Districts)** [Mayor John F. Cook, (915) 541-4145]
