

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.44 (STOPPING, STANDING AND PARKING GENERALLY), SECTION 12.44.160 (PARKING IN ALLEYS) OF THE EL PASO CITY CODE, TO ALLOW PARKING IN ALL ALLEYS. THE PENALTY BEING AS PROVIDED IN SECTION 12.44.160(C) OF THE EL PASO CITY CODE.

BACKGROUND/DISCUSSION:

This ordinance is being amended to update regulations pertaining to parking in alleys citywide. This change clarifies that parking is permitted unless no parking signs are posted. The Engineering Traffic Division supports that this ordinance be amended.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.44 (STOPPING, STANDING AND PARKING GENERALLY), SECTION 12.44.160 (PARKING IN ALLEYS) OF THE EL PASO CITY CODE, TO ALLOW PARKING IN ALL ALLEYS. THE PENALTY BEING AS PROVIDED IN SECTION 12.44.160(C) OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.44 (Stopping, Standing and Parking Generally), Section 12.44.160 (Parking in Alleys) of the El Paso City Code shall be and is hereby amended to delete the following paragraph:
A. All alleys in the parking meter zone, zone A as such district is defined in Schedule XI, Section 12.88.130, shall be governed by the following parking regulations:
2. That Title 12 (Vehicles and Traffic), Chapter 12.44 (Stopping, Standing and Parking Generally), Section 12.44.160 (Parking in Alleys) of the El Paso City Code shall be and is hereby amended to add the following paragraph:
A. Parking is allowed in all alleys and shall be governed by the following parking regulations:
3. Except as expressly herein amended, all other provisions of Title 12 (Vehicles and Traffic), Chapter 12.44 (Stopping, Standing and Parking Generally), Section 12.44.160 (Parking in Alleys) of the El Paso City Code, shall remain in full force and effect.
