SUBJECT: An Ordinance amending Title 9 (Health and Safety), Chapter 9.12 (Food and Food Handling Establishments) to amend section 9.12.125 regarding the adoption and display of fees charged under Chapter 9.12; the penalty being as provided in Section 9.12.890 of the El Paso City Code

BACKGROUND / DISCUSSION: This ordinance is a clean-up provision and is proposed to revise the provisions regarding how the various fees charged under Chapter 9.12 pertaining to food handling establishments are set and listed. This proposed amendment follows the current practice of specifically listing the fee amounts in Schedule C of the budget resolution, rather than listing the amounts in the City Code.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 9 (HEALTH AND SAFETY), CHAPTER 9.12 (FOOD AND FOOD HANDLING ESTABLISHMENTS) TO AMEND SECTION 9.12.125 REGARDING THE ADOPTION AND DISPLAY OF FEES CHARGED UNDER CHAPTER 9.12; THE PENALTY BEING AS PROVIDED IN SECTION 9.12.890 OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Section 9.12.125 (Fee schedule for other required fees) of the El Paso City Code be re-titled and amended as follows:

9.12.125 Fee adoption and display.

A. Fees required under this chapter shall be as adopted from time to time by the city council, as set forth in the annual City budget resolution or other appropriate resolution of the city council. Such fees shall be used to defray the costs of providing the various services and issuing permits under this chapter.

B. Fees for booklets and publications created by the department of public health shall be as set forth in the City budget resolution or other appropriate resolution of the city council, or may be established by the department director in such an amount as to recover the costs of the production of such booklet or publication.

C. A copy of all fees adopted by city council under this chapter shall be displayed at the office of the director of the department of public health or at such other location in the department as established by the department director.

Section 2. Except as expressly herein amended, all other provisions of Title 9 (Health and Safety), Chapter 9.12 (Food and Food Handling Establishments) of the El Paso City Code, shall remain in full force and effect.




