SUBJECT:

APPROVE a resolution / ordinance / lease to do what? OR AUTHORIZE the City Manager to do what? Be descriptive of what we want Council to approve. Include \$ amount if applicable.

Approve an Ordinance authorizing the City Manager to execute a quitclaim (tax resale) deed conveying all right, title and interest in LOT 18, AND THE NORTH 11 FEET OF LOT 19, (4320 SQ.FT.) BLOCK 41, MAGOFFIN, AN ADDITION TO THE CITY OF EL PASO, EL PASO COUNTY, TEXAS to the Centro de Salud Familiar La Fe, Inc., in accordance with Section 34.05 (h) of the Tax Code. Section 34.05 (h) permits the City to sell a property for the total amount of the judgment and the sale of the property does not require the consent of each taxing entity entitled to receive proceeds from the sale.

BACKGROUND / DISCUSSION:

AN ORDINANCE AUTHORIZING THE CONVEYANCE BY THE CITY OF EL PASO TO CENTRO DE SALUD FAMILIAR LA FE, INC. OF LOT 18, AND THE NORTH 11 FEET OF LOT 19, (4320 SQ. FT.), BLOCK 41, MAGOFFIN, AN ADDITION TO THE CITY OF EL PASO, EL PASO COUNTY, TEXAS

Whereas, by Sheriff's Sale conducted on October 4, 1994, the property known as, LOT 18, AND THE NORTH 11 FEET OF LOT 19, (4320 SQ. FT.), BLOCK 41, MAGOFFIN, AN ADDITION TO THE CITY OF EL PASO, EL PASO COUNTY, TEXAS was struck off to the City of El Paso, (the "City") Trustee, pursuant to a delinquent tax foreclosure decree of the 120th Judicial District Court, El Paso County, Texas, and

Whereas, the sum of Ten Thousand Forty-Two Dollars and 42/100 (\$10,042.42) has been tendered by the Centro de Salud Familiar La Fe, Inc., of El Paso County, Texas (the "Centro") for the purchase of said property pursuant to Section 34.05 Texas Tax Code Ann. (Vernon, 1996),

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

That the City Manager is hereby authorized to execute a Quitclaim (Tax Resale) Deed conveying to the Centro, all of the right, title, and interest of the City, and all other taxing units interested in the tax foreclosure judgment in the following described real property:


