Discussion and action on the award of Park Project No. 6A (Solicitation No. 2006-152) to Jan-Car, Inc. of Horizon City, Texas for a total amount of \$612,834.00. P-Plus3 D/I and Parks & Recreation Department recommend approval. This amount represents the Base Bid and Alternates 1 through 11. Improvements will be constructed on 11 different parks in Districts 1, 2 & 8.

P-Plus3 D/I and Parks & Recreation Department recommend the award of contract No. 2006-152, Park Project No. 6A, to the lowest bidder, Jan-Car, Inc. who is also the low responsible, responsive bidder. This contract is for a total amount of \$612,834.00. The following parks will be improved: Buena Vista, Dunn, Grace Chope, Madeline, Murchison, Newman, Pacific, Scenic Drive, Snow Heights, Tom Lea Lower, and Tom Lea Upper.

Scope of Work

The work contemplated under this contract consists of the furnishing of all labor, materials, equipment and tools necessary for the construction of the project titled as follows: Parks Project No. 6A, which includes:

Base Bid I

Buena Vista Park:

Remove and replace fencing on the east and north perimeter. Install rock over slope for erosion control. Raise rock wall (18") in eroded area.

Alternate #1: Replace existing light pole with new concrete light pole and light fixture at the basketball courts.

Dunn Park:

Repair cracks in basketball court. Plant native trees in parkway along El Paso Street. Add drip emitters to existing irrigation system.

Alternate #2: Install Handicapped Accessible benches and trash receptacle.

Alternate #3: Install picnic table on existing concrete slab.

Grace Chope Park:

Provide (2) picnic tables with concrete slabs. Replace backflow preventer and enclosure. Replace existing bench.

Alternate #4: Replace swing set, install concrete edger and 12" of sand in new swing set area.

Madeline Park:

Remove existing asphalt sidewalk and replace with concrete walk. Repair, resurface and restripe existing tennis court. Repair bottom rail of fence at tennis courts. Repair and repoint rock wall at playground. Remove existing asphalt sidewalk and replace with sod. Replace aluminum benches.

Alternate #5: Provide playground equipment for toddlers.

Alternate #6: Remove and replace rockwall around existing playground equipment instead of repointing and repairing the playground rockwall.

Murchison Park:

Install additional benches at lower section and trash cans at both upper and lower sections. Raise, repair and seal rock wall at lower section (by telescopes). Provide concrete bumper stops and stripe parking area. Install concrete bollards and mortared rock. Remove old flagpole and provide new one at new location.

Alternate #7: Remove existing flagpole concrete base.

Newman Park:

Install sidewalk along parkway perimeter. Install new corner concrete to prevent erosion. Replace parkway on west side. Plant additional native trees on west side of playground. Add irrigation for new trees and adjust existing irrigation system to accommodate sidewalk.

Alternate #8: Add playground work – install 16" rock wall, level existing sand, add poured-in-place surfacing and new concrete sidewalk section.

Pacific Park:

Install (1) picnic table at the bottom of the park and (1) at the top. Install (2) trash cans and (4) park-benches. Repair sidewalk/drainage flume along the south side (slope towards park). Paint existing shade structure. Remove and replace concrete sidewalk section in front of playground. Plant (2) native trees by the street. Add irrigation for new trees.

Scenic Drive Park:

Repair rock wall at parking areas as needed. Provide trash cans as required. Repair and cap rock wall as needed throughout the park. Provide park name signs to attach to existing sign walls at both entrances. Replace park rules signs (2).

Snow Heights Parks:

Provide picnic tables. Add 16" rock wall around playground. Provide trash can as required throughout park. Plant native trees through the park. Add concrete between curb and sidewalk along the perimeter of the park. Provide accessibility ramp. Provide irrigation to new trees.

Alternate #9: Replace existing light poles with new concrete light poles and add one concrete light pole.

Alternate #10: Provide shade canopy over existing play structure.

Tom Lea Lower Park:

Provide a complete new irrigation system. Provide mortared stone valley gutter at parking area. Build rock wall as a water buffer along Schuster. Provide sidewalk including handicap ramp from Schuster and Brown to bus stop. Plant additional native trees along park perimeter. Provide irrigation to new trees.

Alternate #11: Provide additional lighting at playground area and parking lot.

Tom Lea Upper Park:

Plant additional native trees in the middle section of the park. Plant ornamentals/ground cover in planters located at both sides of the park. Extend rock wall on both sides of the park. Provide irrigation to new trees. Remount electrical controls and dispose of existing pole.
