**SUBJECT:** Special Privilege SP-06008

This Special Privilege will permit the temporary closure of a portion of San Francisco Avenue (Trolley Lane) for an event sponsored by the El Paso Museum of Art to be held on August 17, 2006 from 5:00 p.m. to 8:00 p.m. and the street closure from 4:00 p.m. to 9:00 p.m. to allow setup and dismantle time.

The El Paso Museum of Art is hosting "3rd Thursdays" events being held every 3<sup>rd</sup> Thursday of the month. This event in particular will require the closure of San Francisco Avenue Festival (Trolley Lane) in order to display the classic car shows being featured.

The event will include the following:

Live music entertainment, food, beverage, and other event festivities.

As consideration for this Special Privilege License the applicant shall provide prior to City Council action the following:

- Submittal of a detailed traffic control plan on or before August 9, 2006, and distribution of the approved plan to the Development Services Department for review and distribution to all applicable Departments;
- Applicant shall temporarily close premises by using the materials and methods approved by the City Engineering Department-Traffic Division; and
- Provide written letters of support of proposed use of public right-of-way from abutting property owners.

**AN ORDINANCE GRANTING A SPECIAL PRIVILEGE AUTHORIZING THE TEMPORARY CLOSURE OF SAN FRANCISCO AVENUE (TROLLEY LANE) BETWEEN EL PASO STREET AND SANTA FE STREET FOR A CITY-SPONSORED ROCKABILLY ROUNDUP AND CLASSIC CAR SHOW EVENT ON AUGUST 17, 2006.**

**WHEREAS**, on August 17, 2006, the El Paso Museum of Art will sponsor an event to be held at the El Paso Museum of Art and some of its surrounding areas, to include the Arts Festival Plaza and a portion of San Francisco Avenue (Trolley Lane), utilizing City facilities, City staff, City resources, and funding for the promotion and presentation of the event; and,

**WHEREAS**, it will be necessary to close a portion of San Francisco Avenue (Trolley Lane) in order to hold this event.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

That a Special Privilege be granted to the City of El Paso Museum of Art for a City-sponsored Rockabilly Roundup and Classic Car Show Event, as follows: (1) to permit the temporary closure of San Francisco Avenue (Trolley Lane) between El Paso Street and Santa Fe Street; and (2) to permit event displays, concession booths, sidewalk vending, and other event activities on Thursday, August 17, 2006, from 4:00 p.m. to 9:00 p.m.


