

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.040 (SCHEDULE IV – PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS), PARAGRAPH 12.88.040 (J) (NO PARKING, 7:00 A.M. TO 4:00 P.M.), SUBPARAGRAPH 12.88.040 (J)(5), LA SUBIDA DRIVE, FROM MONTE MAR PLACE TO A POINT 114 FEET WEST OF ANDALUCIA DRIVE, SOUTH SIDE ONLY, TO REDUCE THE DISTANCE FOR WHICH PARKING IS PROHIBITED. THE PENALTY FOR VIOLATION OF SAME AS PROVIDED IN SECTION 12.85.110 OF THE EL PASO CITY CODE AND AS SET BY RESOLUTION OF THE CITY COUNCIL ON JANUARY 13, 2004.

ORDINANCE NO. _____
AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.040 (SCHEDULE IV - PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS), PARAGRAPH 12.88.040 (J) (NO PARKING, 7:00 A.M. TO 4:00 P.M.), SUBPARAGRAPH 12.88.040 (J)(5), LA SUBIDA DRIVE, FROM MONTE MAR PLACE TO A POINT 114 FEET WEST OF ANDALUCIA DRIVE, SOUTH SIDE ONLY, TO REDUCE THE DISTANCE FOR WHICH PARKING IS PROHIBITED. THE PENALTY FOR VIOLATION OF SAME AS PROVIDED IN SECTION 12.85.110 OF THE EL PASO CITY CODE AND AS SET BY RESOLUTION OF THE CITY COUNCIL ON JANUARY 13, 2004.

WHEREAS, El Paso City Code 12.88.040(J)(5) currently prohibits parking on La Subida Drive from Monte Mar Place to a point 114 feet west of Andalucia Drive (South Side only); and

WHEREAS, the residents fronting La Subida Drive have petitioned the City Engineer, through its Traffic Engineering Division Manager, to reduce the distance of the parking prohibition; and

WHEREAS, the City Engineer, Traffic Engineering Division, has no objections or traffic concerns with the reduction of the parking prohibition as requested,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.040 (Schedule IV - Parking prohibited during certain hours on certain streets), Paragraph 12.88.040 (J) (No Parking, 7:00 a.m. to 4:00 p.m.), Subparagraph (5), La Subida Drive from Monte Mar Place to a point 114 feet west of Andalucia Drive thereof, south side only, of the El Paso City Code shall be and hereby is amended to read as follows:

5. La Subida Drive, from Monte Mar Place to a point 285 feet west of Andalucia Drive thereof, south side only.

2. Except as expressly herein amended, all other provisions of Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.040 (Schedule IV - Parking prohibited on certain hours on certain streets), of the El Paso City Code, shall remain in full force and effect.


