**SUBJECT:**

Approve an Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking Prohibited At All Times On Certain Streets) to add West Drive from a point 300 feet southwest of Garden Place to a point 70 feet northeast, both sides, the penalty being as provided in Section 12.84.010 and Chapter 12.85 of the El Paso City Code.

**BACKGROUND / DISCUSSION:**

The Department of Transportation received a petition from the area residents requesting parking be restricted. Our investigation showed the area was suffering undo influx of drivers patronizing the commercial establishments at North Loop Dr. and parking within the residential area. The residents chose to pursue restricting all parking rather than creating a residential parking district. Department of Transportation recommends approval of this ordinance.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) TO ADD WEST DRIVE FROM A POINT 300 FEET SOUTHWEST OF GARDEN PLACE TO A POINT 70 FEET NORTHEAST, BOTH SIDES, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at times on certain streets), of the El Paso City Code, is amended to add the following paragraph:

West Drive from a point 300 feet southwest of Garden Place to a point 70 feet northeast, both sides.

**Section 2.** Except as herein amended, Title 12, Chapter 12.88, of the El Paso City Code shall remain in full force and effect.







**\*Note to Petitioner:**


