AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) OF THE EL PASO CITY CODE, TO ADD HELEN OF TROY DRIVE. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

**BACKGROUND/DISCUSSION:**

A striping plan has been created for Helen of Troy between Desert North and Redd. The striping plan features a continuous turning lane, two lanes of traffic in each direction, and bike lanes between Northwestern and Redd. The number of lanes does not leave space for vehicles to be parked by the curb without conflicting with traffic in the outer lanes. This plan was discussed by the district representative at the community meeting on July 31, 2008. The attendants of this meeting were in favor of this proposal. Per subdivision code, parking lanes are not included and are not part of the minor arterials. At this time, the Traffic Engineering Division recommends this ordinance be approved.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III, Parking Prohibited at All Times on Certain Streets) of the El Paso City Code shall be and hereby is amended to add the following location:

**Helen of Troy Drive, both sides.**

2. Except as expressly herein amended, all other provisions of Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III - Parking prohibited at all times on certain streets) of the El Paso City Code, shall remain in full force and effect.


