SUBJECT:

Approve an Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or Standing – Tow Away Zone), of the El Paso City Code, to delete Paragraph 112 thereby allowing parking on Father Rahm Avenue between El Paso Street and the first alley to the west of El Paso Street, south side only, the penalty being as provided in section 12.84.010 of the El Paso City Code.

BACKGROUND / DISCUSSION:

This ordinance is provided to rescind ordinance #17066 passed by City Council on February 3, 2009 that restricted parking on Father Rahm Avenue as part of the Sun Metro SMART 101 bus service. This area is no longer needed for a bus stop. Department of Transportation recommends rescinding this ordinance and turn this area back to public (metered) parking.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING – TOW AWAY ZONE), OF THE EL PASO CITY CODE, TO DELETE PARAGRAPH 112 THEREBY ALLOWING PARKING ON FATHER RAHM AVENUE BETWEEN EL PASO STREET AND THE FIRST ALLEY TO THE WEST OF EL PASO STREET, SOUTH SIDE ONLY, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing – Tow-away zone), is hereby amended to delete the following paragraph:

112. Father Rahm Avenue between El Paso Street and the first alley to the west of El Paso Street, south side only.

Section 2. Except as herein amended, Title 12, Chapter 12.88 of the El Paso City Code shall remain in full force and effect.


