Solicitation 2008-157 is extended until July 9, 2008 because lack of response. Bid opened July 9 and only one bid was received.



- **El Paso Honda, El Paso, TX 915-591-6100:** Does not sell Honda motorcycles. Have to go to Mr. Motorcycles.
- **Rudolph Honda, El Paso, TX 915-544-9100:** Does not sell Honda motorcycles. Have to go to Mr. Motorcycles.
- **Borman Honda, Las Cruces, NM 800-376-2277:** Does not sell Honda motorcycle but recommended Las Cruces Motorsports 575-524-3626 in Las Cruces (2125 S. Valley Dr., Las Cruces, NM 88005). Las Cruces Motorsports said that they will look into it.
- **BMW of El Paso, El Paso, TX 915-887-6100:** Said that they sold vehicles only and not BMW motorcycles.
- **Kawasaki Edge Motorsports, El Paso, TX 915-593-1024:** Kawasaki no longer offers Police Motorcycles specifications.
