AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.040, SCHEDULE IV (PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS), PARAGRAPH J (NO PARKING 7:00 AM TO 4:00 PM) OF THE EL PASO CITY CODE, TO DELETE CERTAIN SUBPARAGRAPHS OF PARAGRAPH J. THE PENALTY BEING AS PROVIDED IN SECTION 12.85.110 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BACKGROUND / DISCUSSION:

This ordinance is to delete certain paragraphs from the existing ordinance (12.88.040 paragraph J) which currently reads "No Parking 7am to 4pm Mon-Fri, Not to include Sundays and Legal Holidays". It was discovered that several streets listed have signs that read "No Parking 7am to 4pm, Mon – Fri, School Days Only" which do not fully reflect the existing ordinance. It is the recommendation of the Engineering Traffic Division to submit and add a new schedule that reads "No Parking 7am to 4pm, Mon-Fri, School Days Only." See the companion ordinance request in this City Council agenda.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.040, SCHEDULE IV (PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS), PARAGRAPH J (NO PARKING 7:00 AM TO 4:00 PM) OF THE EL PASO CITY CODE, TO DELETE CERTAIN SUBPARAGRAPHS OF PARAGRAPH J. THE PENALTY BEING AS PROVIDED IN SECTION 12.85.110 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.040 Schedule IV (Parking prohibited during certain hours on certain streets), Paragraph J (No parking, 7:00 a.m. to 4:00 p.m) of the El Paso City Code shall be and hereby is amended to delete the following subparagraphs of Paragraph J:

J. No parking, 7:00 a.m. to 4:00 p.m.

- 2. Santa Maria Drive, south side only, between La Paz Drive and Venado Drive;**
- 3. Ben Proctor Drive from Missy Yvette Drive to Peter Cooper Drive, both sides;**
- 4. Entire length of Frank Cordova Circle, both sides, all of Mike Andrade Place and all of Luis Gomez Place;**
- 5. La Subida Drive, from Monte Mar Place to a point 285 feet west of Andalucia Drive thereof, south side only;**
- 9. Sara Danielle Drive, both sides;**
- 10. Both sides of Dos Rios Drive, from a point 50 feet west of Chato Villa Drive to Peter Cooper Drive;**
- 11. Elon Lane, the entire length of cul-de-sac;**
- 12. Mark Wallace Lane, the entire length of cul-de-sac;**
- 13. McVeigh Way, the entire length of cul-de-sac;**
- 14. Sam Horrell Way, the entire length of cul-de-sac;**
- 15. Missy Yvette north of Ben Proctor, east side from addresses 1444 through 12148, and the west side from addresses 1445 through 12153; and**
- 16. Firehouse Drive, from Montwood Drive and Saul Kleinfeld, east side only.**

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), 12.88.040 Schedule IV (Parking Prohibited During Certain Hours On Certain Streets) Paragraph J (No parking, 7:00 a.m. to 4:00 p.m) of the El Paso City Code shall remain in full force and effect.


