SUBJECT:

That City Council approve the purchase of Accu-Tab Blue Scale Inhibitor Tablets from Triple-S Janitorial Supplies (sole source) for the Parks & Recreation Department totaling \$57,753.60. The Accu-Tab will be used for swimming pool water disinfectant, water treatment, oxidizing agent, and chemical intermediate.

BACKGROUND / DISCUSSION:

The Parks & Recreation Department needs Accu-Tab Blue Scale Inhibitor for the Accu-Tab Chlorination Systems installed at all of the City's 14 swimming pool facilities. This purchase will ensure manufacturer warranty and National Science Foundation (NSF) Certification of the systems.

This purchase of \$57,753.60 will be funded through Fund 01101; Dept. ID 51010364; Acct 503126; Class 51000. These funds are budgeted in the Parks and Recreation Department FY10 budget. The Purchasing Division has approved this as a sole source purchase.


