Competitive Sealed Proposal: The selection of **Medlock Commercial Contractors, LLC** as the offeror that submitted the highest ranked proposal for the construction of **Armijo Branch Library Computer Lab Addition & Chihuahuita Community Center HVAC Remodeling, Proposal No. 2009-277**, as per recommendations from the Engineering Department, Parks and Recreation Department and Library Department and that the City Engineer and staff be authorized to proceed with negotiations of a contract in accordance with Section 271.116, Texas Local Government Code.

BACKGROUND / DISCUSSION:

Armijo Branch Library Computer Lab Addition

This project is a CDBG 34th Year Grant. The project consists of construction of 1,600 SF addition on the North portion of the Armijo Library located at 620 East Seventh St. The new addition will be utilized as the new computer laboratory with 25 workstations, complete with network connections, projector screen, and new HVAC system. Computers units are not part of this project and will be provided by Library Department.

Chihuahuita Community Center Remodeling and HVAC Rehabilitation.

This project is a CDBG 34th Year Grant. The project consists of the removal of the existing shower room on both men and women's restroom and make it a part of the new enlarged class room and exercise room. Exercise equipments are not part of this project. The project will also convert the existing evaporative cooling system of the Community Center into a refrigerated cooling system, complete with new duct work.

The Community Center will also get new ADA ramps, new door fixtures, new drinking fountain, new kitchen counters, and remodeling of restrooms to comply with ADA requirements. All ADA work will be funded under CIP 2006 CO's.

The project was bid using the Competitive Sealed Proposal process required by City Ordinance for all vertical construction. The Competitive Sealed Proposal method is a two step process that allows several factors to be considered in determining the offeror that provides the highest ranked proposal for the City. The first step in the process is a review and ranking of factors including the offeror's price performance on City projects, contractor building construction experience and the provision for employee health insurance. As part of the first step, Engineering requests City Council approval to negotiate with the highest ranking offeror. In the second step of the process Engineering presents the scope of work and negotiated price to City Council for approval.

Scope of Work

BASE BID - 1

ARMIJO LIBRARY COMPUTER LAB ADDITION:

The construction of the proposed Armijo Library Computer Lab addition is composed of adding approximately 1,600 Sq. Ft space to accommodate computers work stations. The work consists of removing existing aluminum curtain wall system, exterior doors and exterior light fixtures. The site development will also consist of removing the existing concrete slab, landscaping and existing utilities.

The new work includes clearing, grading and drainage, landscaping, concrete sidewalks, concrete pads, concrete block, metal stud framing, steel, roofing membrane, roofing accessories, sheet metal, aluminum doors and frames, aluminum curtain wall and storefront framing, hardware, glazing, exterior and interior finishes, air conditioning, plumbing, electrical power, lighting systems, and fire alarm system as shown on the working drawing. For further additional requirements and provisions, refer to construction documents.

BASE BID- 2

CHIHUAHUITA COMMUNITY CENTER REMODELING & HVAC REHABILITATION:

The work consists primarily of converting the existing facility's mechanical system from evaporative cooling to a new refrigerated cooling/heating system. Additional work is the removal of the existing men's shower area to increase the meeting room's size and the removal of the existing women's shower area to increase the exercise room size. Demolishing of existing restrooms and remodeling to meet with state regulation and standards compliance. Lastly to remove existing light fixtures and provide new energy efficient lighting fixtures to the space as shown on the construction work drawings. For further additional requirements and provisions, refer to the construction documents.

BASE BID - 3

ARMIJO LIBRARY COMPUTER LAB ADDITION:

To furnish and install 25 workstations plus 1 instructors desk in computer area one and two. Workstations need to be anchored and secured to the concrete slab. Refer to the construction documents for additional requirements and provisions:

OPTION #1 – (12) WORKSTATIONS & PRINTER DESK

Furnish and install twelve (12) workstations and printer desk in addition to Base Bid 3. Provide all work surfaces, raceway panels, baserail assemblies, and electrical connections.

The scope of work, the score sheet used for this evaluation and bid tabulation are attached, as well as the user department, consultant and Engineering's certification. **Medlock Commercial Contractors, LLC** received the highest score (83.75) for the project.

After City Council approves this item, staff will be reviewing and negotiating the scope and terms of the contract with the contractor and undergo a Value Engineering process. Value Engineering will allow the City to substitute/eliminate materials and processes to lower the cost of the project while still accomplishing the project objective. Staff will return with the negotiated project scope, price and terms of the contract for recommendation of award at a future City Council meeting in accordance with Section 271.116 Texas Local Government Code.


