Summary

The contract resulting from this bid solicitation will be a fixed-price, single purchase (one-time) contract. Thirty-seven bids were received, which included thirty local vendors. Absolute lowest bid received was from Sofa Mart at \$25,372.20, but vendor failed to submit General Liability Insurance as required by the bid specifications which reads "YOUR BID SHALL INCLUDE A CURRENT COPY OF YOUR GENERAL LIABILITY INSURANCE CERTIFICATE", and therefore deemed non-responsive and invalid.

Solicitation was awarded to Factory Direct Home Furnishings at \$25,690.00, which was the lowest responsive, responsible offer meeting specifications






