The cost incurred for this property at **133 Elvira Way** includes \$3,403.44 performed by the Street Department and \$1,046.85 performed by the City Clerks Office and Development Services Department for a total cost of \$4,450.29.

RESOLUTION

WHEREAS, in accordance with Chapter 18.50 of the City Code, the Building and Standards Commission of the City of El Paso, by Order dated the 28th day of April, 2010, after due notice and hearing, issued an order to JUAN HUERTA and BALTAZAR HUERTA, record Owners of the hereinafter described property that the structure be secured within thirty (30) days and that the premises be cleaned of all weeds, trash, and debris within thirty (30) days, and the Owners and any mortgagee or lienholder having failed after due notice to comply with such ORDER, the Street Department of the City of El Paso has been ordered to proceed to secure and clean the premises of all weeds, trash, and debris.

WHEREAS, the Director for the Development Services Department has reported the cost of doing such work in the amount hereinafter set forth;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That the City Council determines the actual cost of the securing of the structure within thirty (30) days and cleaning the premises of all weeds, trash and debris from the property, more particularly described as:

Lot 4, Block 2, Salas Subdivision in the City of El Paso, El Paso County, Texas according to the map and plat thereof filed for records in the back of Book 551, Deed Records and now in Record in Plat Book 13, at Page 24, in the Office of the County Clerk of El Paso county, Texas, more particularly described as 133 Elvira Way, El Paso, Texas,

to be \$3,403.44, performed by the Street Department of the City of El Paso, and \$1,046.85, performed by the City Clerk's Office and Development Services Department, making a total of \$4,450.29. The City Council finds that the work was completed on the 28th day of June, 2010, and approves the costs.

2. That the City Council, in accordance with Texas Local Government Code §214.001(n), declares the above total amount of FOUR THOUSAND FOUR HUNDRED FIFTY AND 29/00 DOLLARS (\$4,450.29) to be a lien on the above-described property.

3. That the City Clerk is directed to give notice of this lien by filing a copy of this Resolution for record with the County Clerk.

4. That all records of the City Clerk's Office relating to the proceeding against the above-described property are made a part of this Resolution by reference.
