Fred Jackson got his start in the airport food service industry at the age of only 13, when he worked as a busboy at Houston Hobby Airport. Today, Fred serves as the Delaware North – Travel Hospitality Services El Paso International Airport General Manager. For 17 years, he's played the lead role for all Delaware North operations at the airport. His experience in the industry is unparalleled, beginning his management career upon graduating from North Eastern Junior College in 1971, when he started with Dobbs House at Houston Intercontinental Airport (now George Bush Intercontinental Airport). Over the past 35 years, he worked with many airport management companies, including Dobbs House, ARA Services, Continental Airlines, ATS Services and 20 years with Delaware North –THS.

Fred has received several awards for his leadership in the Food services industry. In 1999, he was awarded the first place in Retail and Specialty in the Airport Council International's Excellence in Airport Concessions Contest. In 2000, he received the CA One Services Customer Service Award for El Paso International Airport. In 2002, he won the CA One Services Central/Southwest Region Unit of the Year Award and the Unit of the Year Award – all for El Paso International Airport. In 2001 and 1997, he was recognized as Outstanding Restaurateur for El Paso by the Texas Restaurant Association. In 2004 and 2005, he received the Delaware North-THS Achievement Award, and in 2004, the Delaware North-THS Customer Service Award.

Fred's professional affiliations are also extensive. He currently serves on the State Board of Directors for the Texas Restaurant Association and the El Paso Board of Directors for the El Paso Restaurant Association. He has twice been elected as President of the El Paso Restaurant Association. He was appointed to the Greater El Paso Civic Convention and Tourism Advisory Board by the City Council of El Paso, the El Paso City Health Department Advisory Committee to review and develop City of El Paso health codes and fees and the El Paso Community College District Food Service/Restaurant Advisory Committee.

Fred is a certified Professional Food Manager – CPMF by NSF. He is Servsafe certified, City of El Paso-County Health Management certified, Texas Alcoholic Beverage Commission Seller Certified.

For the past 17 years, Fred has been involved in several local charities such as the Ronald McDonald House, Lee Moor Children Home and the Family Crisis Center. He is a member of the Texas – El Paso Restaurant Association, the El Paso Hispanic Chamber of Commerce and Discover El Paso Association.
