SUBJECT:

That the City Manager be authorized to sign an Amendment to an Agreement by and between the **CITY OF EL PASO** and **LICON ENGINEERING CO., INC.**, for citywide geotechnical and materials testing services on an "as needed" basis to increase the amount of total compensation under the Agreement by an additional **SEVENTY FIVE THOUSAND AND NO/100 DOLLARS (\$75,000.00)**.

BACKGROUND / DISCUSSION:

On January 3, 2006, the City entered into a Agreement for Geotechnical and Testing Laboratory Services for a period of one year with the consultant, Licon Engineering Co., Inc.. The City desires to increase the amount of total compensation under the Agreement by an additional \$75,000 and to engage the Consultant to be available, on an "as needed" basis, to perform geotechnical and material testing investigations in connection with City of El Paso construction projects. The original contract capacity is \$250,000. To date approximately \$181,000 has been expended of the \$250,000 contract capacity. With this increase the total contract capacity will be \$325,000.

The increase is needed because we have several upcoming capital improvement projects including some of the storm 2006 flood control projects that will begin construction. The remaining original contract capacity is not sufficient to provide thorough geotechnical and material testing services. The geotechnical and material testing services are necessary for quality assurance.

PRIOR COUNCIL ACTION:

City Council approved the original Agreement on January 3, 2006.





) FOR GEOTECHNICAL AND TESTING
COUNTY OF EL PASO) LABORATORY SERVICES

THIS First Amendment is made this _____ day of _____, 2006, by and between THE CITY OF EL PASO, hereinafter referred to as the "Owner", and LICON ENGINEERING CO., INC , hereinafter referred to as the "Consultant".

WHEREAS, on January 3, 2006, the Owner entered into an Agreement for GEOTECHNICAL AND TESTING LABORATORY SERVICES, hereinafter referred to as the "Agreement", with the Consultant to perform geotechnical and testing laboratory services for a period of one (1) year; and,

WHEREAS, the Owner desires to increase the compensation under the agreement so that additional services may be rendered on an as needed basis; and,

WHEREAS, the Consultant is willing to perform the additional services under the same terms and conditions of the Agreement,

NOW, THEREFORE, both the Owner and Consultant agree to amend the Agreement as follows:

1. Paragraph III, Services, subparagraph 1 is amended to read: services as described in Attachment "A" of the Agreement.

III. COMPENSATION

1. The total value for the term of the Agreement, to include any term which extends the Agreement, shall not exceed THREE HUNDRED AND TWENTY FIVE THOUSAND AND NO/100 DOLLARS (\$325,000.00).
2. Except as expressly herein amended, all terms and conditions of the Agreement shall remain in full force and effect.
