SUBJECT:

APPROVE a resolution establishing salaries for the full-time Associate Municipal Court Judges and for the Associate Municipal Court Judges when they serve at the temporary court session created under Municipal Court No. 4.

BACKGROUND / DISCUSSION:

This resolution sets the salaries for the Associates Judges when they serve at the temporary court sessions created by ordinance for Municipal Court No. 4 as well as when they serve full time. The divisions for Municipal Court No. 4 are separate courts that will be presided over by Associate Judges, as assigned by the Presiding Judge. Two courts will operate continuously on a full time basis, as directed by the Presiding Judge. The third court will operate during the December holiday season. Full time Associate Judges preside over the arraignment court and serve as night magistrate.

Ordinance creating three divisions of Municipal Court No. 4 was approved by Council on August 22, 2006. Approval of full time Associates was approved in the Budget Resolution.


