RESOLUTION

WHEREAS, in accordance with Chapter 18.50 of the El Paso Municipal Code, the Building Standards Commission of the City of El Paso, by Order dated the 7th day of May, 2002, after due notice and hearing, ordered ELVIRA DORA VALENZUELA, record Owner of the hereinafter described property that the Building(s) be re-secured within thirty (30) days and clean the premises of all weeds, trash, and debris all within thirty (30) days, and the Owner having failed after due notice to comply with such ORDER, any mortgagees, lienholders and other persons having an interest in the property have an additional ten (10) days to re-secure the Building(s) and clean the premises of all trash, debris, and the mortgagees, lienholders and other persons having an interest in the property failed after due notice to comply with such ORDER, the Street Department of the City of El Paso has been ordered to proceed to re-secure the Building(s) and clean the premises of all weeds, trash, and debris.

WHEREAS, the Director for the Development Services Department has reported the cost of doing such work in the amount hereinafter set forth;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That the City Council determines the actual cost of re-securing the Building(s) and cleaning the premises of all weeds, trash and debris from the property, more particularly described as:

Lot 13 EXC S 2 Feet, Block 26, Thomas Manor #10 Subdivision, City of El Paso, El Paso County, Texas, municipally known and numbered as 349 Maricela Drive, El Paso, Texas,

to be \$277.47, performed by the Street Department of the City of El Paso, making a total of \$277.47. The City Council finds that the work was completed on the 16th day of August, 2007, and approves the costs.

2. That the City Council, in accordance with Texas Local Government Code §214.001(n), declares the above total amount of TWO HUNDRED SEVENTY-SEVEN AND 47/100 DOLLARS (\$277.47) to be a lien on the above-described property.

3. That the City Clerk is directed to give notice of this lien by filing a copy of this Resolution for record with the County Clerk.

4. That all records of the City Clerk's Office relating to the proceeding against the above-described property are made a part of this Resolution by reference.




