Two items above have been highlighted because they represent a selection that requires some explanation. Item 3b, under the 56-hour employee uniforms, 100% Cotton Navy Blue Polo Shirt, at \$14.94 ea. is *not* the lowest bid listed for that item, but is an offering that meets our quality standards. Neither Bazaar's lowest bid polo at \$11.99 nor Uniforms of Texas' polo at \$12.50 met our needs for fade resistance.

The other item in question is item 7a under the Common items group, the solid navy blue baseball cap. Samples submitted from the other vendors did not meet our expectations for quality. Bazaar's offering at \$3.46 is the lowest bid for an acceptable baseball cap, so we recommend award to Bazaar for the blue baseball cap as well as the white one.
