BACKGROUND / DISCUSSION:

On June 7, 2010 the City notified Currey Adkins LP, that pursuant to Article 2-Term and Termination of the contract between the City and Currey Adkins, LP, the City may terminate the contract without cause if responses from a proposed solicitation were more favorable to the City than the current contract. On June 16, 2010 the City released Request for Proposal No. 2010-181R, Transport Medical Billing, Collections, and ePCR services.

El Paso City Council awarded Request for Proposal Number 2003-208R, Fire Department Billing and Accounts Receivable Management System and Services to Currey Adkins Cook on August 26, 2003.
