AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) OF THE EL PASO CITY CODE, TO ADD A NEW LOCATION ON TRAWOOD DRIVE BETWEEN PICO ALTO DRIVE AND YARBROUGH DRIVE, BOTH SIDES. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

A resident of the neighborhood requested parking be removed along this section of Trawood Drive adjacent to Vista Del Sol Park. The Engineering Traffic Division recommends the removal of parking to improve visibility along the park and provide for safer access throughout this section of Trawood Drive.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III, Parking Prohibited at All Times on Certain Streets) of the El Paso City Code shall be and hereby is amended to add the following paragraph:

**Trawood Drive, between Pico Alto Drive and Yarbrough, both sides.**

2. Except as expressly herein amended, all other provisions of Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III - Parking prohibited at all times on certain streets) of the El Paso City Code, shall remain in full force and effect.


