That the City exercises the option to extend the existing one year Agreement for Geotechnical and Testing Laboratory Services on an as needed basis by and between the CITY OF EL PASO and LICON ENGINEERING CO., INC, for one additional one (1) year period.

BACKGROUND / DISCUSSION:

On January 3, 2006, the City entered into a Agreement for Geotechnical and Testing Laboratory Services for a period of one year with the consultant, Licon Engineering Co., Inc.. The City desires to extend the agreement for an additional one (1) year and to engage the Consultant to be available, on an "as needed" basis, to perform geotechnical and material testing investigations in connection with the City's construction projects, as the need may rise from time to time, and provide other laboratory testing services as required and as specified in purchase orders, from time to time, hereinafter collectively referred to as the "Project". The current capacity on this contract is \$80,703.00. This extension will increase the contract capacity to \$330,703.00.

PRIOR COUNCIL ACTION:

City Council approved the original Agreement on January 3, 2006 and approved the first amendment on November 7, 2006.


