

AN ORDINANCE REAFFIRMING THE AUTHORIZATION, APPROVED IN ORDINANCE NO. 016484, FOR THE CITY OF EL PASO TO SELL A 12.197-ACRE PARCEL OF LAND, MORE OR LESS, BEING A PORTION OF TRACT 6B, S.A. & M. G. RAILWAYS SURVEY COMPANY NO. 268 AND A PORTION OF TRACT 3B, JOHN WHITTAKER SURVEY, NO. 134, CITY OF EL PASO, EL PASO COUNTY, TEXAS TO HAM MANAGEMENT, LLC, AND CORRECTING AN ERROR IN THE LEGAL DESCRIPTION TO INCLUDE "ALL OF TRACT 10C2" AND "NOW KNOWN AS TRACT 3B2" IN THE IDENTIFIED LEGAL DESCRIPTION AND SURVEY.

WHEREAS, the City of El Paso received an independent appraisal of a 12.197-acre parcel of land, more or less, in Northwest El Paso; and

WHEREAS, in accordance with Section 272.001 of the Texas Local Government Code, the City of El Paso advertised and solicited bids for the purchase of the identified 12.197 acre parcel of land; and

WHEREAS, on Oct. 24, 2006, the El Paso City Council approved Ordinance No. 016484 which authorized the sale of the identified property to HAM Management, LLC, as the highest bidder; and

WHEREAS, an error was identified in the attached legal description and the survey because the words "all of Tract 10C2" and "now known as Tract 3B2" had been inadvertently omitted; however, the error did not revise the total acreage of the land nor the configuration of the identified Plat Survey,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

That the City Manager be authorized to sign a revised Contract of Sale and all other necessary documents, in a form approved by the City Attorney's Office, conveying a 12.197-acre parcel of land, more or less, being a portion of Tract 6B and all of Tract 10C2, S.A. & M. G. Railways Survey Company No. 268 and a portion of Tract 3B, now known as Tract 3B2, John Whittaker Survey, No. 134, being more particularly described in Exhibit "A" attached hereto and made a part hereof, City of El Paso, El Paso County, Texas to HAM Management, LLC.

Property Description: A portion of Tract 6B and all of Tract 10C2, S.A. & M.G. Railways Company Survey No. 268 and a portion of Tract 3B now known as Tract 3B2, John Whittaker Survey No. 134, EL Paso, EL Paso County, Texas.

METES AND BOUNDS DESCRIPTION

The parcel of land herein described is a portion of Tract 6B and all of Tract 10C2, S.A. & M.G. Railways Company Survey No. 268 and a portion of Tract 3B now known as Tract 3B2, John Whittaker Survey No. 134, EL Paso, EL Paso County, Texas and is more particularly described by metes and bounds as follows:

Commencing at an existing city monument lying on the centerline intersection of Waterhouse Drive and Bartlett Drive; Thence, 170.07 feet along said centerline of Bartlett Drive and along the arc of a curve to the right, having a radius of 1672.45 feet, a central angle of 5° 49' 35" and a chord which bears South 02° 54' 47" East, a distance of 170.00 feet to a point; Thence, North 90° 00' 00" West, a distance of 35.00 feet to a point lying on the westerly right-of-way line of Bartlett Drive, said point being a set 1/2-inch iron with SLI plastic cap stamped "TX 2998", also being the TRUE POINT OF BEGINNING of this description;






AMENDED CONTRACT OF SALE

THIS Agreement is entered into this ____ day of _____, 2006, by and between the **City of El Paso**, hereinafter referred to as the "City" and **HAM MANAGEMENT, LLC**, hereinafter referred to as the "Buyer."

WHEREAS, on Oct. 24, 2006, the El Paso City Council approved Ordinance No. 016484 which authorized the sale of the identified property to HAM Management, LLC, as the highest bidder and the City and the Buyer executed a contract for the sale of the property (the "First Contract"); and

WHEREAS, an error was identified in the attached legal description and the survey because the words "all of Tract 10C2" and "now known as Tract 3B2" had been inadvertently omitted; however, the error did not revise the total acreage of the land nor the configuration of the identified Plat Survey and the parties desire to amend the First Contract to correct this error,

NOW, THEREFORE, for and in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Description of Property. The City hereby agrees to sell and convey and the Buyer hereby agrees to acquire free and clear of any liens or encumbrances, the following described real property located in El Paso County, Texas:

A 12.197 acre parcel of land, more or less, being a portion of Tract 6B and all of Tract 10C2, S.A. & M. G. Railways Survey Company No. 268 and a portion of Tract 3B, now known as Tract 3B2, John Whittaker Survey, No. 134, being more particularly described in Exhibit "A" attached hereto and made a part hereof, City of El Paso, El Paso County, Texas,

together with any interest in (i) all improvements, if any, (ii) all right, title and interest of the City in and to any easements, appurtenances, and rights-of-way, and all interests in, on or to, any land, highway or street, in, on, across, in front of, abutting, or adjoining any such real property, and (iii) all ground water, water rights or rights to surface water will be subject to all easements, restrictions, reservations, rights of way, dedications and other encumbrances of record or apparent upon the real property (including any right to drill a well and produce therefrom any quantity of groundwater), all of such property, hereinafter collectively referred to as the "Property", save and except the following:

1.1 Radioactive Materials. Any conveyance of this Property will be subject to a restrictive covenant to the effect that the Buyer, its successors or assigns, will not, for a period of at least seventy-five (75) years, discard, place, or store upon such

land, any radioactive material or other materials which would contaminate or otherwise damage the ground water supply or resources of the City.

- 1.2 Surveys. The Buyer accepts responsibility for conducting its own archeological and environmental surveys of the Property. Any mitigation of any conditions on the Property, including archeological sites or, without limitations, adverse environmental conditions, shall be at the expense of the Buyer who shall take the Property subject to all existing conditions. The Buyer accepts responsibility for its determination of the nature and extent of any archeological sites, or without limitations, any adverse environmental conditions by its complete inspection of the Property.

2. Amount of Payment of Purchase Price. The purchase price for the Property shall be **FOUR HUNDRED SIX THOUSAND NINE HUNDRED FIFTY AND NO/100THS DOLLARS (\$406,950.00)**, which sum includes the appraisal services fee of \$1,650.00 and surveying costs of \$2,050.00, plus any additional closing costs as identified in Paragraph 5.2.

- 2.1 Payment of Sales Price. The full amount of the purchase price will be payable in cash at the closing.

- 2.2 Earnest Money. The City acknowledges the receipt of earnest money paid to the City in by the Buyer in the amount of **TWENTY THOUSAND, THREE HUNDRED FORTY-EIGHT AND 00/100 DOLLARS (\$20,348.00)**, which will be credited to the purchase price at the time of closing.

3. Conditions to the Buyer's Obligations. The obligations of the Buyer hereunder is to consummate the transaction contemplated herein are subject to the satisfaction of each of the following conditions, any of which may be waived, in whole or in part, in writing by the Buyer, at or prior to Closing.

- 3.1 Title Insurance. Within fourteen (14) days after receipt of written notification of the City's acceptance of the Buyer's offer, the Buyer shall provide the City with all information necessary to close the sale with the intent that, without good cause existing or further delay, it is anticipated that the City and the Buyer will close within thirty (30) days from the date of the approval of the City Council of an ordinance authorizing the sale of the Property. The Buyer at its expense will order a title commitment ("Commitment"), accompanied by copies of all recorded documents affecting the Property for the issuance of an Owner's Policy of Title Insurance with respect to the Property, in an amount to be decided by the Buyer ("Owner's Policy").

- 3.2 Title Objections. The Buyer will give the City written notice after it receives the Commitment that the condition of the title set forth in the Commitment is or is not satisfactory. In the event the Buyer states that the condition is not satisfactory, the Buyer will specifically set forth in such notice the defect or exception to title that is

deemed objectionable. City may promptly undertake to eliminate or modify all unacceptable matters to the reasonable satisfaction of the Buyer. Otherwise, this condition will be deemed acceptable and any objection by The Buyer will be deemed waived.

3.3 Covenants.

- 3.3.1 Buyer is to construct Bartlett Drive extending from its south terminus at Dianjou Drive and connect to north street beginning at Waterhouse Drive.
- 3.3.2 Bartlett Drive cross section is a 44-foot wide arterial with sidewalks.
- 3.3.3 Construction is to be in accordance with subdivision design standards and specifications as published by the City of El Paso Engineering Department.
- 3.3.4 No over-width pavement reimbursement will apply.
- 3.3.5 Road construction should include all utility infrastructures to prevent future pavement cuts.
- 3.3.6 Bartlett Drive extension construction is to be accomplished within two (2) years after closing of sale.
- 3.3.7 If the construction of Bartlett Drive extension has not been completed by the end of the first two (2) year term, a two (2) year extension for construction can be requested by the Buyer, in writing, to:

Request must be considered and granted by City Council. The written request must be submitted sixty (60) calendar days prior to the expiration of the initial two (2) year term and must include a detailed explanation of delays and justification for an extension.

- 3.3.8 If Buyer fails to accomplish the road extension within the approved timeline(s), the property shall revert back to the City of El Paso.

4. Representations of City. The City hereby represents, to the extent allowed by law, to The Buyer that to the best of its knowledge, as follows:

- 4.1 Parties in Possession. At the time of closing, other than the Buyer, there are no parties in possession of any portion of the Property as lessees, tenants at sufferance, or otherwise.
- 4.2 Mechanic's Lien. (i) No action has been taken, suffered or permitted by or on behalf of the City, the effect of which would be to establish or cause the inception or priority of any mechanic's or materialmen's lien, statutory, constitutional or otherwise, or other lien, charge or encumbrance upon the Property or any part thereof or interest therein; and (ii) no liens or lien claims, choate or inchoate, arising from the City's actions or otherwise, exist or can exist for the benefit of mechanics or materialmen in regard to the Property; and (iii) except as expressly disclosed in the documents relating to this transaction, the City has not entered into any contracts or agreements relating to the use or ownership of the Property or by which any person or entity agreed to provide labor, services or materials in regard to the Property or the business of the City.
- 4.3 Litigation. There is no pending or contemplated litigation before or by any court of law pertaining to the Property or which involve incidents occurring on the Property including, but not limited to, claims of damage to persons or Property.
- 4.4 Bills Paid. At closing, there will be no unpaid bills or claims in connection with any repair or operation of the Property.
- 4.5 Compliance Law. All laws, ordinances, rules and regulations of any Government or any agency, body or subdivision thereof, bearing in the development of the Property, have been complied with.
- 4.6 Taxes. While the City owned the Property, the Property was exempt from ad valorem taxes.
- 4.7 Pre-Closing Claims. City agrees that the Buyer's acceptance of title to the Property under the conveyance documents should not create any liability on the Buyer's part to third parties that have claims of any kind against the City in connection with the Property. The City hereby expressly disclaims any and all liability to third parties that have any claims against the City.
- 4.8 Condition of Property Prior to Closing. Prior to Closing, the City shall not create or permit to be created any easement or other condition affecting the Property without the prior written consent of the Buyer.
- 4.9 "As Is, Where Is." THIS CONTRACT IS AN ARMS-LENGTH AGREEMENT BETWEEN THE PARTIES. THE PURCHASE PRICE WAS BARGAINED ON THE BASIS OF AN "AS IS, WHERE IS" TRANSACTION. THE BUYER ACCEPTS THE AS IS, WHERE IS, AND WITH ALL FAULTS, AND EXCEPT AS TO THE WARRANTY OF TITLE,

WITHOUT ANY REPRESENTATIONS OR WARRANTIES OF WHATSOEVER KIND, EXPRESS OR IMPLIED, WRITTEN OR ORAL, IT BEING THE INTENTION OF THE CITY AND THE BUYER TO EXPRESSLY NEGATE AND EXCLUDE ALL REPRESENTATIONS AND WARRANTIES OF ANY KIND, INCLUDING, BUT NOT LIMITED TO THOSE REGARDING: (A) THE CONDITION OF THE PROPERTY AND THE CONDITION; (B) THE SUITABILITY OF THE PROPERTY FOR ANY AND ALL ACTIVITIES AND USES WHICH THE BUYER MAY CONDUCT THEREON; (C) THE COMPLIANCE OF OR BY THE PROPERTY OR ITS OPERATION WITH ANY LAWS, RULES, ORDINANCES OR REGULATIONS OF ANY APPLICABLE GOVERNMENTAL AUTHORITY OR BODY; AND (D) THE HABITABILITY, MERCHANTABILITY, MARKETABILITY, PROFITABILITY OR FITNESS FOR A PARTICULAR PURPOSE OF THE PROPERTY. THE BUYER FURTHER ACKNOWLEDGES AND AGREES THAT, HAVING BEEN GIVEN THE OPPORTUNITY TO INSPECT THE PROPERTY, THE BUYER IS RELYING SOLELY ON ITS OWN INVESTIGATION OF THE PROPERTY AND NOT ON ANY INFORMATION PROVIDED OR TO BE PROVIDED BY THE CITY. THE BUYER FURTHER ACKNOWLEDGES AND AGREES THAT ANY INFORMATION PROVIDED OR TO BE PROVIDED WITH RESPECT TO THE PROPERTY WAS OBTAINED FROM A VARIETY OF SOURCES AND THAT THE CITY HAS NOT MADE ANY INDEPENDENT INVESTIGATION OR VERIFICATION OF SUCH INFORMATION AND MAKES NO REPRESENTATIONS AS TO THE ACCURACY OR COMPLETENESS OF SUCH INFORMATION. THE CITY IS NOT LIABLE OR BOUND IN ANY MANNER BY ANY VERBAL OR WRITTEN STATEMENTS, REPRESENTATIONS OR INFORMATION PERTAINING TO THE PROPERTY, OR THE OPERATION THEREOF, FURNISHED BY ANY BROKER, AGENT, ATTORNEY, EMPLOYEE OR OTHER PERSON. IT IS UNDERSTOOD AND AGREED THAT THE PURCHASE PRICE FOR THE PROPERTY REFLECTS THAT ALL OF THE PROPERTY IS SOLD BY THE CITY AND PURCHASED BY THE BUYER SUBJECT TO THE FOREGOING.

4.10 Survival. All agreements of the City made in this document shall survive the execution and delivery hereof and the Closing hereunder, until such time as all of the obligations of the signatories hereto shall have lapsed in accordance with their respective terms or shall have been discharged in full.

5. Closing. The closing of this transaction ("Closing") shall take place at the offices of Lone Star Title Company, 601 N. Mesa, El Paso, Texas 79901 on or before the later of: (i) thirty (30) days from the Effective Date; or (ii) thirty (30) days after the execution of this Agreement by the City, subject to delays due to the City's efforts to cure any title objection under section 2.2.

- 5.1 Possession. Possession of the Property will be transferred to the Buyer upon Closing.
- 5.2 Closing Costs.
- (a) All recording fees arising from the recordation of documents necessary to show good title to the Property in the Buyer shall be paid by the Buyer.
 - (b) Premiums and other charges for the issuance of the Owner's Policy of Title Insurance for the Property shall be paid by the Buyer.
 - (c) Any fees for surveys shall be paid by the Buyer.
 - (d) The fees for advertising in the amount of \$132.92, and any other costs the City may have incurred in the preparation for the sale of the Property (Solicitation No. 2006-180) shall be paid by the Buyer.
 - (e) The appraisal services fee of \$1,650.00 and surveying costs of \$2,050.00, which are included in the purchase price of the property.
- 5.3 City's Obligations. At Closing, the City shall deliver to the Buyer a duly executed and acknowledged Special Warranty Deed conveying the Property and any related easements, free and clear of any and all liens, encumbrances, conditions, easements, assessments, and restrictions, except for (i) ad valorem taxes for the year of Closing, if any, which shall be assumed by the Buyer upon closing, (ii) the standard printed exceptions contained in the usual form of the Owner's Policy, and (iii) any other exceptions set forth in the Title Policy which the Buyer has approved pursuant to Paragraph 4 above.
- 5.4 Other Obligations. Each party shall do all other acts, or deliver any other instruments or documents required or helpful to be done or delivered, in order to consummate this transaction.
6. Default.
- 6.1 Breach by City. In the event that the City shall fail to fully and timely perform any of its obligations under this Agreement, or shall fail to consummate the sale of the Property for any reason, except the Buyer's default, or the termination of this Agreement in accordance with its terms, the City agrees to absorb the cost of the appraisal services and other costs the City may have incurred in preparation for the sale of the Property. In addition, the City will return the earnest money provided by the Buyer.

6.2 Breach by the Buyer. In the event that the Buyer shall fail to fully and timely perform any of its obligations under this Agreement, or shall fail to consummate the sale of the Property for any reason, except the City's default, or the termination of this Agreement in accordance with its terms, the City may at its sole and exclusive remedy terminate the Contract and recover the Earnest Money as damages.

7. Miscellaneous.

7.1 Notice. Any notice, demand, direction, request, or other instrument authorized or required by this Agreement to be given to or filed with either party, shall be deemed to have been sufficiently given or filed for all purposes, if and when personally delivered or sent by certified mail, postage prepaid, return receipt requested, to the address specified below or at such other address as may be designated in writing by the parties:

8. Entire Agreement/Governing Law. This Agreement constitutes the entire agreement between the parties, and supersedes all prior agreements and understandings, written or oral, regarding the subject matter of this Agreement, and may be amended or supplemented only by an instrument in writing, executed by the party against whom enforcement is sought. This Agreement shall be governed in all respects, including validity, interpretation and effect, by and shall be enforceable in accordance with the laws of the State of Texas.

8.1 Time. Time is of the essence of this Agreement and each and every provision hereof.

8.2 Severability. If any provision of this Agreement shall be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining portion shall not in any way be affected or impaired.

8.3 Survival of Provisions. The terms contained in this Agreement, including without limitation, representations, warranties, covenants and agreements of the parties, shall survive the Closing and shall not be merged therein. In case any one or more of the provisions contained in this contract for any reason is held invalid, this

invalidity will not affect any other provision of this Contract, which will be construed as if the invalid or unenforceable provision had never existed.


- 8.4 Binding Effect. This Agreement shall be binding upon the parties hereto and their respective successors and assigns.






