**AN ORDINANCE REPEALING ORDINANCE NUMBER 015987, WHICH CREATED THE WORKFORCE RETRAINING ADVISORY COMMITTEE, AND PROVIDED FOR MEMBERSHIP AND TERMS, OFFICERS, RULES AND REGULATIONS, ADMINISTRATION, AND DUTIES OF THE BOARD.**

**WHEREAS**, on January 18, 2005, the El Paso City Council adopted Ordinance 015987 establishing the Workforce Retraining Advisory Committee ("WRAC"), an advisory committee charged with making recommendations to the Mayor and City Council with respect to specific problems which exist in the local workforce regarding the education and retraining of displaced workers;

**WHEREAS**, the El Paso City Council has determined that matters of local workforce development, education, training and services are being addressed by the Upper Rio Grande Workforce Development Board;

**WHEREAS**, members of WRAC have been appointed to the Upper Rio Grande Workforce Development Board to provide direct input;

**WHEREAS**, the El Paso City Council has determined that the efforts of WRAC are a duplication of the work done by the Upper Rio Grande Workforce Development Board;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

That Ordinance Number 015987 is repealed in its entirety for the purposes of abolishing the Workforce Retraining Advisory Committee.


