A. El Paso Coalition for the Homeless review of Point in Time homeless survey data and policy considerations recommendations

Camille Castillo from the Homeless Coalition updates the committee on the outcome of the Point in Time Survey done in 2015 and advises them the numbers for the first 2016 survey have not been finalized but does not expect for the numbers to be as high as last year.

B. Fair Housing Issues for Veterans in private rentals

Camille Castillo elaborates on barriers the coalition faces when trying to accommodate veterans in rental properties. There is a lack of landlords in El Paso who know of agencies that can provide assistance. They might be reluctant to rent to veterans as some are not established in a job or they might have mental health issues. There seems to be enough federal dollars to assist in rapid rehousing veterans but it is the consensus of the coalition and the committee that El Paso should have transitional living facilities to house them and ensure veterans receive proper case management to avoid a high rate of recidivism.

The committee requests for the Homeless Coalition to provide a list of the most critical barriers so they can add to the quarterly report that will be submitted to city council.
