7. **Discussion and Action: VAAC Committee Letter/Report for City Council**
  - \* Excused/Unexcused Absences – Motion made by Mr. Sparks and seconded by Mr. Loyd to add an action item on every agenda regarding absences. Motion made by Board Secretary Mr. Fierro and seconded by Mr. Sparks that members email him and copy the city secretary to ensure someone receives prior notice of an absence.

*Formal vote will take place during the VAAC meeting on excusing the members that notified city staff that they are not able to attend the meeting.*
  - \* Request for City to include a Veterans Affairs Tab on the first page of the city's website – Mr. Sparks would like it to direct veterans to a resource page with numbers to call for assistance.
  - \* Committees progress regarding transportation and housing issues – Mr Escobedo from Sun Metro states the transit passes agreement was finalized & distributed to participating agencies. Once Sun Metro receives a signed agreement an ID will be issued in 3 days. Motion made by Mr. Kennedy and seconded by Ms. Rocha to issue swipe cards to the veterans who will be utilizing the discount transit service. **Motion passes unanimously.**
  - \* VAAC term limit to 4 years rather than 2 years – Motion made by Mr. Loyd and seconded by Ms. Ramos to keep term limits to 2 years for now. **Motion passes unanimously.**
  - \* Mr. Sparks would like for city council to consider having an independent housing policy for veterans with special needs or circumstances.
