- Coates Drive Sidewalk Improvements - from Doniphan Drive to site of new school
- Memorial Park Tennis Courts Improvements - 1701 Copia Street
- Memorial Senior Center Improvements - 1800 Byron Street
- Lower Dyer Neighborhood Revitalization Strategy Area - from Copia Street to Polk Avenue and Van Buren Avenue to Hayes Street
- Colonia Verde Park Improvements - 5452 Ketchikan Street
- Pueblo Viejo Park Improvements - Old Middle Drain between Presa Place and Candelaria Lane
- Pecan Grove II Park Improvements - 9100 Betel Drive
- Lunch at Hometown Buffet - 9120 Viscount Boulevard
- Rosedale Manor Street and Drainage Improvements - Barton Street from Carolina Drive to dead end; and Elliot Street from Barton Street to Cadwallader Drive
- Hidden Valley Park Improvements - 200 Coconut Tree Lane
- Mary Jeanne Lane Street and Drainage Improvements - from Toni Place to Becky Lane
- Buena Vista Street and Drainage Improvements - from Alameda Avenue to Cesar Chavez Memorial Highway
- De Vargas Park Improvements - 643 De Vargas Drive
- Encino Street and Drainage Improvements - from Edna Avenue to Elena Avenue
- Clardy Fox Library Improvements - 5515 Robert Alva Avenue
- Chamizal Neighborhood Revitalization Strategy Area - Alameda Avenue to Paisano Drive and U.S. Highway 54 to Laurel Street
