

**RESOLUTION CANVASSING RETURNS
OF THE 2013 CITY GENERAL ELECTION**

WHEREAS, the City Council of the City of El Paso ordered an election to be held in said City on May 11, 2013, for the purpose of electing certain City officials for the terms as established by and in accordance with the Charter of the City of El Paso; and

3. That in the case of the offices of **Mayor, Representative District 2, Representative District 4, and Representative District 7** no person received more than a 50% majority of all votes cast for the candidates for such offices, and accordingly no one for these offices is declared elected and a runoff election is to be called by the City Council in accordance with the Texas Election Code; and that the number of votes cast for each person who was a candidate for such offices, according to the returns, is shown in paragraph 2 hereof.

4. That in the case of the following offices, the following persons who received more than a 50% majority of the votes cast for candidates for such offices are hereby declared elected to such offices for the ensuing terms, or until the election and qualification of their successors, subject to the proper issuance of certificates of election by the presiding officer, and that the number of votes cast for each person who was a candidate for such offices, according to the returns, is shown in paragraph 2 hereof:
